Introduction

This publishing contract, the "contract", is entered into as of contract created date by and between Pixel

Glyph Press, an imprint of Daniel Rg Crandall Publisher, the "Publisher", and The Author, the "Author".

This publishing contract governs the publication of the work(s) "The Work" designated by working title in the invoice notes, with payment by the Author and acknowledgement by the Publisher being considered agreement to the terms set forth here.

Grant of Rights

The Author grants Pixel Glyph Press, an imprint of Daniel Rg Crandall Publisher full right and title to the following, in perpetuity:

- The right to publish, sell, and profit from the listed works in all languages and formats in existence today and at any point in the future.
- To create or devise modified, abridged, or derivative works based on the works listed.
- To extend the right to publish to vendors and distributors without providing compensation to The Author

These rights are granted by The Author on behalf of him/herself and their successors, heirs, executors, and any other party who may attempt to lay claim to these rights at any point now or in the future.

Any rights not granted to Pixel Glyph Press, an imprint of Daniel Rg Crandall Publisher above remain with The Author, including the right of authorship and ownership of the original text.

The rights granted to Pixel Glyph Press, an imprint of Daniel Rg Crandall Publisher by The Author shall not be constrained by geographic territories and are considered global in nature.

Author Compensation

Pixel Glyph Press, an imprint of Daniel Rg Crandall Publisher shall provide The Author with advanced drafts and designs for approval prior to publishing and upon initial public release. In good faith, these advanced copies shall be delivered to The Author as follows:

- Design proof PDF files provided through digital download link.
- Two copies of the first edition print, delivered by US Postal mail or similar package delivery service within the domestic Unites States..

Pixel Glyph Press, an imprint of Daniel Rg Crandall Publisher agrees to provide The Author with limited design and distribution digital and print services related to The Work.

Royalty-Free Publishing, Distribution and Design Service: Pixel Glyph Press, an imprint of Daniel Rg Crandall Publisher is investing the time and resources to design a book for a small fee and make it available in the market at a competitive price as a print-on-demand product for the duration of The Work's useful life.

Manuscripts

The Author agrees to deliver a completed manuscript in English, the "Manuscript" to Pixel Glyph Press, an imprint of Daniel Rg Crandall Publisher prior to publication. The Manuscript may be delivered via certified mail or email in printed or digital format.

Additionally, The Author shall deliver all artwork, prefaces, references, acknowledgments, and other "frontmatter" or "backmatter" at a date to be determined by Pixel Glyph Press, an imprint of Daniel Rg Crandall Publisher.

Should Pixel Glyph Press, an imprint of Daniel Rg Crandall Publisher deem any delivered material to be unacceptable for any reason, The Author shall be granted a period of time (to be determined by Pixel Glyph Press, an imprint of Daniel Rg Crandall Publisher) to correct such defects. If The Author fails to correct defects in the time granted, Pixel Glyph Press, an imprint of Daniel Rg Crandall Publisher reserves the right to make changes to this book publishing contract with cause, and make minor updates and edits to the book content to fulfill publishing and distribution requirements.

Publication

Pixel Glyph Press, an imprint of Daniel Rg Crandall Publisher shall have the exclusive right to edit or modify the delivered materials at their discretion prior to publication. The Author agrees to pay a fair and predetermined fee in U.S. Dollars for design and publishing services and shall have the right to review any modifications and grant approval prior to initial publication.

While The Author shall have the right to review and approve any changes to content, the work's format, cover design, and final artwork, Pixel Glyph Press, an imprint of Daniel Rg Crandall Publisher shall retain full right to manufacture, distribute, market, and sell the completed work as they deem necessary.

Pixel Glyph Press, an imprint of Daniel Rg Crandall Publisher agrees to provide page proofs of the material prior to publication. These proofs shall include all content, including artwork. The Author agrees to review and return these proofs to Pixel Glyph Press, an imprint of Daniel Rg Crandall Publisher within 30 days. If The Author makes or requests changes to the content aside from typographical errors in excess of 5% of the typesetting or design cost, then The Author agrees to pay such costs to Pixel Glyph Press, an imprint of Daniel Rg Crandall Publisher.

Pixel Glyph Press, an imprint of Daniel Rg Crandall Publisher agrees to make all reasonable effort that the works covered under this book publishing contract will be published within one year of delivery of the initial manuscript.

Pixel Glyph Press, an imprint of Daniel Rg Crandall Publisher agrees to consult with The Author regarding marketing the published works, but reserves the right to make final decisions regarding sales and marketing of The Work. The Author grants Pixel Glyph Press, an imprint of Daniel Rg Crandall Publisher the right to use The Author's name and likeness as they see fit for marketing purposes.

Copyright

Pixel Glyph Press, an imprint of Daniel Rg Crandall Publisher shall include a copyright notice in The Authors's name on all published copies of the works in accordance with United States copyright regulations.

Distribution

Pixel Glyph Press, an imprint of Daniel Rg Crandall Publisher shall provide The Author with a digital link from which the book may be purchased at reasonable market rates.

Warranties & Indemnity

The Author warrants that the works governed by this book publishing contract are their sole intellectual property, that no other similar agreements governing these works exist, and that the works are not in the public domain.

Additionally, The Author warrants that The Work does not infringe on copyrights, trademarks, or other intellectual rights of any third parties. If the works governed by this book publishing contract contain statements presented as fact, The Author warrants that such statements are true and accurate.

Furthermore, The Author agrees to refrain from entering into agreements with third parties that conflict with the terms of this book publishing contract.

Publisher's Right to Cancel

Pixel Glyph Press, an imprint of Daniel Rg Crandall Publisher shall have the right to cancel this book publishing contract should they deem that The Author has failed to uphold it's terms specifically of providing content and approving drafts, after granting The Author a period of at least 90 days to correct such issues. Should this book publishing contract be cancelled, all rights and responsibilities granted to Pixel Glyph Press, an imprint of Daniel Rg Crandall Publisher shall revert to The Author.

General Terms

This book publishing contract represents the entire agreement between The Author and Pixel Glyph Press, an imprint of Daniel Rg Crandall Publisher.

This contract may not be altered, amended, or otherwise modified except through written form requiring signature by both parties.

Should multiple individuals be considered The Author of the works governed by this book publishing contract, each of those individuals shall be liable for adhering to the terms of this contract.

Pixel Glyph Press, an imprint of Daniel Rg Crandall Publisher and The Author shall be granted an extension on any time-sensitive duties related to this book publishing contract should circumstance beyond their control interfere with their ability to execute their contractual obligations.

All notices related to this contract shall be delivered via certified mail or email.

This book publishing contract shall be considered legally binding upon both parties heirs, partners, associates, subsidiaries, successors, executors, and licensees.

This contract shall be governed by the laws of Tennessee.

Any disputes related to this contract shall be resolved through binding neutral arbitration.

Acceptance
